

## **Contests and Sweepstakes**

To participate in various activities on the Sites, including contests and sweepstakes, users may be required to complete a registration process and may receive/select a "user name" and/or password. You will be fully responsible for all uses of your registration and for any activity that occurs under your password or account, whether or not authorized by you. You further agree to immediately notify Nexstar of any unauthorized use of your registration and/or password. You acknowledge that you are subject to Nexstar's Privacy Policy. .

PLEASE READ CAREFULLY. By entering a contest sponsored by Nexstar, or any of the television stations owned by Nexstar, or any third party affiliated with Nexstar for the purposes of sponsoring a contest, you agree to abide by these Official Rules and the decisions of Nexstar and its designated judges, which are final and binding on all matters.

and affiliated companies, and advertising and promotion agencies, and each of their respective officers, directors, employees, representatives, licensees, assignees and agents (collectively, the "Released Parties") will have no liability whatsoever for, and are released and shall be held harmless by entrants from and against any liability, for any injuries, losses or damages of any kind, to persons, including death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or from participation in this contest or in any contest-related activity.
